

FISCAL SUMMARY December 2017

- 1. Current Revenue for December 2017 was \$64.4m, \$2.6m above the target for the month of December and \$5.5m above the 2016 December collections.
- 2. Capital projects financed by grants in December 2017 amounted to \$10.9m.
- 3. Total expenditure for the month of December was \$54.9m.
- 4. A primary surplus of \$25.6m was realized for the month of December 2017.
