

FISCAL SUMMARY March 2017

- 1. Current Revenue for March 2017 was \$70.5M, which was \$8.4M above the target and \$8.6M more than the collections for March 2016.
- 2. Grants for March 2017 amounted to \$6.9M, which was \$6.9m below the targeted \$13.8M.
- 3. Total expenditure for the month of March was \$55.3M, \$11M below the targeted \$66.3M.
- 4. A primary surplus of \$26.8M was realized for the month of March 2017, exceeding the projected surplus of \$15.9M.
