

FISCAL SUMMARY

- Revenue collection performed well relative to projections (\$256.5M compared with target of \$237.6M).
- Grant receipts lagged behind (Collections of \$27.5M compared with \$37.5M).
- Current spending was \$240.9 million (\$18.4 million less than target – backpay included).
- 1. Capital expenditure reached \$80.3 million (38% of target).
