

FISCAL SUMMARY March 2015

- 1. Revenues for the month of March surpassed its target (collections of \$54.1M as against target of \$45.9M). Compared to March of 2014, revenues were 20% higher.
- 2. Grant receipts in March 2015 fell short of target of \$13.4M. However, the \$9.2M received was \$4.4M more when compared to March of 2014.
- 3. Current expenditure was within target, amounting to \$57.7M as against target of \$59.2M. The level of current spending in March of this year was \$2.2M higher than the corresponding period of last year.
- 4. Capital expenditure of EC\$18.8M was below target \$25.4M. This level of capital spending was higher than the \$16.0M realized in March of 2014.
