

## FISCAL SUMMARY February 2022

- Current Revenue for February 2022 was \$57.9m, which was \$3.8m more than the February 2022 target and \$4.9m more than the collections for February 2021.
- 2. Total Grants received in February 2022 amounted to \$6.9m, which was \$5.4m less than the target and \$9.6m less than the amount spent in February 2021.
- 3. Total Current Expenditure, excluding principal repayments for the month of February was \$51.8m, which was \$2.6m less than the \$54.4m targeted.
- 4. Capital Expenditure in February 2022 was \$20.6m, \$6.6m more than the amount spent in February 2021 but below the \$22.6m targeted for the month this year.
- A primary balance (including grants) of \$-5.8m was recorded for the month of February 2022, which was \$2.5m more than the month's target and \$-11.6m less than the amount recorded in February 2021.
- 6. Principal Repayments on Debt for February 2022 was \$13.0m, while interest payments totaled \$2.2m.
