

FISCAL SUMMARY January 2022

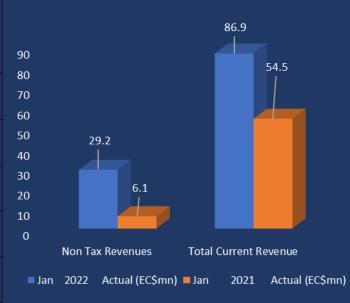
- 1. Current Revenue for January 2022 was \$86.9m, which was \$25m more than the January 2022 target and \$31.4m more than the collections for January 2021. Of the \$86.9m collected \$17.5m of total revenue represents one off receipts in the form of dividends.
- 2. Total Grants spent in January 2022 amounted to \$5.9m, which was \$2.7m less than the target and \$1.0m less than the amount spent in January 2021.
- 3. Total Current Expenditure, excluding principal repayments for the month of January was \$46.7m, which was \$3.0m lower than the \$49.7m targeted.
- 4. Capital Expenditure in January 2022 was \$17.7m, \$10.6m more than the amount spent in January 2021 and above the \$16.4m targeted for the month this year.
- 5. A primary balance (including grants) of \$30.8m was recorded for the month of January 2022, which was \$26.4m more than the month's target and \$19.2m more than the amount recorded in January 2021.
- 6. Principal Repayments on Debt for January 2022 was \$27.2m, while interest payments totaled \$2.4m.

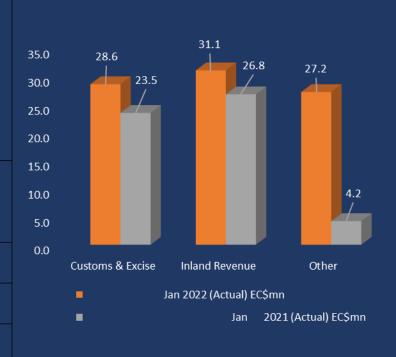
