

FISCAL SUMMARY March 2022

- 1. Current Revenue for March 2022 was \$80.0m, which was \$5.0m more than the March 2022 target and \$9.9m more than the collections for March 2021.
- 2. Total Grants received in March 2022 amounted to \$100.6m of which \$81.0m was current grants/budgetary support.
- 3. Total Current Expenditure, excluding principal repayments for the month of March was \$52.2m, which was \$4.5m less than the \$56.7m targeted.
- 4. Capital Expenditure in March 2022 was \$39.7m, \$25.5m more than the amount spent in March 2021 and above the \$26.2m targeted for the month this year.
- 5. A primary balance (including grants) of \$92.9m was recorded for the month of March 2022, which was \$82.3m more than the month's target and \$74.3m more than the amount recorded in March 2021.
- 6. Principal Repayments on Debt for March 2022 was \$4.0m, while interest payments totaled \$4.2m.

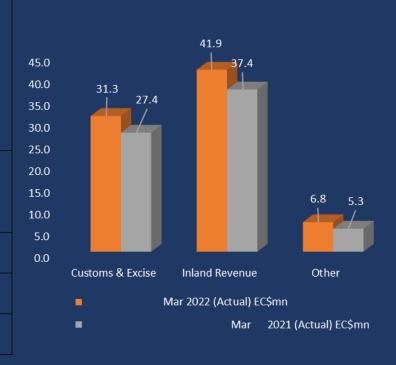
