

FISCAL SUMMARY January 2023

- 1. Current Revenue for January 2023 was \$87.5m, which was \$4.2m more than the 2023 target and \$0.2m less than the collections for January 2022.
- 2. Total Grants in January 2023 amounted to \$1.0m which was \$2.3m less than the target and \$4.9m less than the actual in January 2022.
- 3. Total Current Expenditure, excluding principal repayments for the month of January was \$48.7m, which was \$7.1m less than the \$55.8m targeted.
- 4. Capital Expenditure in January 2023 was \$13.9m, \$3.8m less than the amount spent in January 2022 and below the \$15.3m targeted for the month this year.
- 5. A primary balance (including grants) of \$28.7m was recorded for the month of January 2023, which was \$10.5m more than the month's target and \$2.9m less than the amount recorded in January 2022.
- 6. Principal Repayments on Debt for January 2023 was \$22.2m, while interest payments totaled \$2.8m.
