



# FISCAL SUMMARY


## June 2023

1. Current Revenue for June 2023 was \$131.2m, which was \$44.4m more than the 2023 target and \$66.6m more than the collections for June 2022.
2. Total Grants in June 2023 amounted to \$1.9m which was \$2.2m less than the target and \$11.2m less than the actual in June 2022.
3. Total Current Expenditure, excluding principal repayments for the month of June was \$51.4m, which was \$7.8m less than the \$59.2m targeted.
4. Capital Expenditure in June 2023 was \$19.0m, \$16.4m less than the amount spent in June 2022 and above the \$18.9m targeted for the month this year.
5. A primary balance (including grants) of \$64.1m was recorded for the month of June 2023, which was \$47.4m more than the month's target and \$70.9m more than the amount recorded in June 2022.
6. Principal Repayments on Debt for June 2023 was \$4.1m, while interest payments totaled \$1.4m.


