

FISCAL SUMMARY March 2023

- 1. Current Revenue for March 2023 was \$121.2m, which was \$24.8m more than the 2023 target and \$40.3m more than the collections for March 2022.
- 2. Total Grants in March 2023 amounted to \$3.2m which was \$2.3m less than the target and \$97.4m* less than the actual in March 2022.
- 3. Total Current Expenditure, excluding principal repayments for the month of March was \$58.4m, which was \$5.8m less than the \$64.2m targeted.
- 4. Capital Expenditure in March 2023 was \$30.7m, \$9.1m less than the amount spent in March 2022 and above the \$25.4m targeted for the month this year.
- 5. A primary balance (including grants) of \$40.0m was recorded for the month of March 2023, which was \$22.6m more than the month's target and \$53.7m less than the amount recorded in March 2022.
- 6. Principal Repayments on Debt for March 2023 was \$6.7m, while interest payments totaled \$4.7m.
