The Government of Grenada has received financing from the World Bank toward the cost of the OECS Skills & Innovation Project, and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) include the expertise of a National Project Coordinator, in accordance with the Loan Agreement and World Bank Procurement Regulation for IPF Borrowers to coordinate and oversee the day-to-day management, general administration, and logistical requirements of the Grenada portion of the OECS Skills and Innovation Project. The project will be implemented during the period 2024 to 2030, and the successful candidate is expected to commence duties in August 2024.

- A Bachelor's degree in Education, Public Administration, Business Management, or a related field with 10 years' experience. Or
- A Master's degree in Education, Public Administration, Business Management, or a related field with 5 years' experience
- Professional certification in Project Management would be an advantage.
- At least 5 years of progressive experience in project coordination or management, preferably in the education sector or related fields.
- Knowledge of Grenada's post-secondary education systems and issues would be an advantage.
- Experience in managing projects funded by multilateral development banks.
- Experience in the monitoring and evaluation of projects is highly desirable.
