

OVERVIEWJune 2025

- 1. From January to June 2025, Grenada's fiscal performance was generally in line with targets.
- 2. In June 2025, current revenue collections exceeded projections, mainly due to performance in taxes on International Trade & Transactions and IMA revenues, Higher-than-expected grant inflows were also realized. Current expenditures were kept below target levels, while capital spending surpassed projections.
- 3. For June 2025, the primary and overall deficits were recorded at -\$14.8 million and -\$16.4 million, respectively.
- 4. Cumulatively, for the January to June 2025 period, both the primary and overall balances remained well within the established targets.





FISCAL SUMMARY June 2025

- 1. Current Revenue for June 2025 was \$93.8m, which was \$1.9m more than the 2025 target and \$21.4m less than the collections for June 2024.
- 2. Total Grants in June 2025 amounted to \$6.5m which was \$1.9m more than the target and \$6.1m more than the actual in June 2024.
- 3. Total Current Expenditure, excluding Principal Repayments for the month of June was \$71.4m, which was \$10.2m less than the \$81.6m targeted.
- 4. Capital Expenditure in June 2025 was \$45.3m, \$19.1m more than the amount spent in June 2024 and above the \$29.6m monthly target .

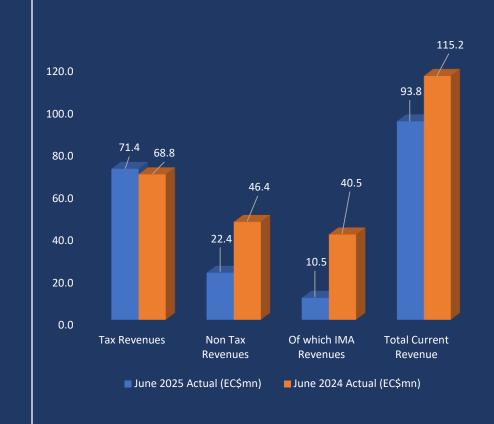
- 5. A Primary Balance (including Grants) of -\$14.8m was recorded for the month of June 2025, which was \$3.7m less than the month's target and \$37.1m less than the amount recorded in June 2024.
- 6. Total Principal Payments on Debt for June 2025 was \$2.1m, while Interest Payments totaled \$1.6m.
- 7. The Primary Balance, year-to-date, was -\$11.7m, which was \$43.5m more than targeted but \$230.5m less than the amount recorded for January to June 2024.
- 8. The Overall Balance, year-to-date, was -\$30.4m, significantly better than the -\$79.0m targeted for the period.
- 9. Total Principal and Interest Payments year-to-date were \$58.8m and \$18.7m, respectively.

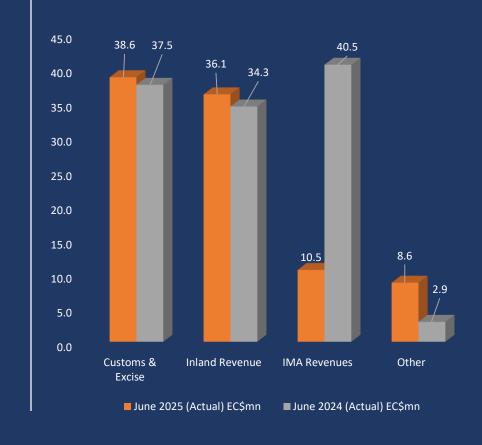
