

OVERVIEW March 2025

- 1. Grenada's fiscal outturn remained above target for the January–March 2025 period.
- 2. In March 2025, current revenue collections fell below projections, driven by weaker non-tax miscellaneous revenues and lower-than-expected grant inflows were realized. Current expenditures slightly exceeded target levels, while capital spending fell short of projections.
- 3. A primary deficit stood at -\$3.4 million and an overall deficit of -\$7.9 million were recorded for March; both outcomes were better than budgeted. On a cumulative basis, both the primary and overall balances continued to outperform fiscal benchmarks.





FISCAL SUMMARY March 2025

- 1. Current Revenue for March 2025 was \$105.7m, which was \$4.7m less than the 2025 target and \$7.1m less than the collections for March 2024.
- 2. Total Grants in March 2025 amounted to \$0.7m which was \$5.1m less than the target and \$2.8m less than the actual in March 2024.
- 3. Total Current Expenditure, excluding Principal Repayments for the month of March was \$91.0m, which was \$1.8m more than the \$89.2m targeted.
- 4. Capital Expenditure in March 2025 was \$23.3m, \$2.4m more than the amount spent in March 2024 but below the \$39.4m targeted for the month this year.

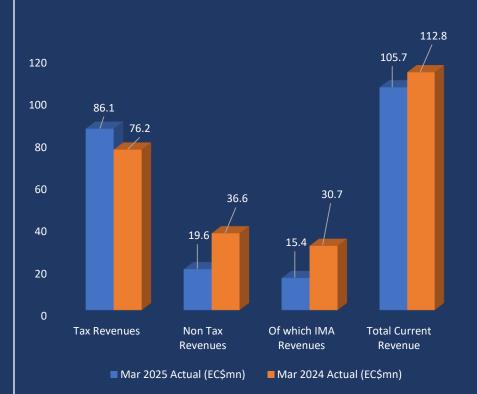
- 5. A Primary Balance (including Grants) of -\$3.4m was recorded for the month of March 2025, which was \$3.2m more than the month's target but \$36.3m less than the amount recorded in March 2024.
- 6. Total Principal Payments on Debt for March 2025 was \$1.8m, while Interest Payments totaled \$4.5m.
- 7. The Primary Balance, year-to-date, was \$19.2m, which was \$28.2m more than targeted but \$91.5m less than the amount recorded for January to March 2024.
- 8. The Overall Balance, year-to-date, was \$8.8m, exceeding the -\$20.4m targeted for the period.
- 9. Total Principal and Interest Payments year-to-date were \$26.6m and \$10.4m, respectively.
