- 1. The Government of Grenada has received financing from the World Bank toward the cost of the OECS Regional Health Project, and intends to apply part of the proceeds toward payments under the contract for Upgrade works at Sauteurs Health Centre.
- 2. The Ministry of Mobilisation, Implementation and Transformation in collaboration with the Ministry of Health, Wellness and Religious Affairs now invites sealed Bids from eligible Bidders for Upgrade works at Sauteurs Health Centre to improve its functionality, structural soundness and make the facilities greener.

The works include comprehensive architectural, structural, electrical, and mechanical upgrades, namely:

- (a) repairs to the structural elements of the four existing buildings on site;
- (b) new covered walkway between (a) the main Admin Building and the Nurses Residence and (b) Main Admin Building and the Maternity Ward;
- (c) Pavement works to existing access road and reinstate surface drainage;
- (d) interior improvements featuring new wall, floor, and ceiling finishes, hurricane impact-resistant windows, new doors, and anti-microbial laminated cabinetry;
- (e) improvement of potable water and wastewater plumbing, and wastewater collection and treatment system;
- (f) improvement to electrical wiring, control systems, and power connections;
- (g) supply and installation of an emergency supply power (e.g. diesel generator);
- (h) improvement of HVAC systems using high efficiency units;
- (i) replacement of sanitary fixtures with water efficient, hospital-grade fixtures;
- (j) installation of solar systems (photovoltaic and water heating).

The health centre is located in Sauteurs Main Road, La Fortune, of the parish of Saint Patrick on the north side of the island of Grenada.

The rehabilitation works are expected to be completed within eight (8) months.

Applicants are expected to meet the following, among others, key qualification requirements:

- (a) Experience under construction contracts in the role of prime contractor, JV member, subcontractor, or management contractor for at least the last five (5) years, starting 1<sup>st</sup> January 2020.
- (b) At least two (2) similar contracts of minimum value of XCD1,700,000 each or one (1) contract of minimum value of XCD3,400,000 that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1<sup>st</sup> January 2016 and bid submission deadline.
- (c) access to, or availability of, liquid assets, unencumbered real assets, lines of credit, and other financial means (independent of any contractual advance payment) sufficient to meet the construction cash flow requirements estimated as one million Eastern Caribbean Dollars (XCD1,000,000) for the subject contract net of the Bidder's other commitments
- (d) Minimum average annual construction turnover of two million and eight hundred thousand Eastern Caribbean Dollars (XCD2,800,000), calculated as total certified payments received for contracts in progress and/or completed for the best three (3) years within the last five (5) years, divided by three (3) years
- (e) For the above and any other contracts (substantially completed and under implementation) as prime contractor, joint venture member, or sub-contractor between 1<sup>st</sup> January 2016 and bid submission deadline, a minimum construction experience in the following key activities successfully completed for retrofitting of health, education and social centres and hotels of similar size in any 12 months within the specified period:
  - (i) demolition and reconfiguration of internal and external walls
  - (ii) road paving and drainage / civil works
  - (iii) HVAC improvement
  - (iv) rewiring of electrical systems and installation of energy-efficient luminaires
  - (v) installation of diesel generators of at least 30 kW
  - (vi) replacement of sanitary fixtures, and commercial water distribution
  - (vii) replacement of wastewater plumbing and treatment systems
  - (viii) replacement of roofing (frame, roof sheeting, insulation, guttering, installation of hurricane straps)
  - (ix) installation of UPVC seamless vinvl flooring
  - (x) installation of solar systems (photovoltaic and water heating).

Activities (ii) - (x) may be met through specialized sub-contractors.

- (f) experience in managing ES risks and impacts in the following aspects for contracts (substantially completed and under implementation) as prime contractor, joint venture member, or Subcontractor between 1<sup>st</sup> January 2016 and bid submission deadline:
  - (i) traffic management
  - (ii) occupational health and safety
  - (iii) waste management.

- 3. Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" dated September 2023 ("Procurement Regulations") and is open to all Bidders as defined in the Procurement Regulations. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
- 4.
