

FISCAL SUMMARY June 2018

- 1. A primary surplus of \$20.1m was realized for the month of June 2018.
- 2. Current Revenue for the month was \$63.1m, which was \$5.7m more than the collections for June 2017.
- 3. Grants received amounted to \$4.2m, \$0.7m above the amount received in June 2017.
- 4. Total expenditure for the month was \$50.3m of which current expenditure was \$46.3 million and capital expenditure was \$4.0m. The total expenditure for June 2018 was \$1.8m above the amount spent in June 2017.
