

FISCAL SUMMARY April 2021

- 1. Current Revenue for April 2021 was \$57.8m, which was \$8.2m more than the April 2021 target and \$13.2m more than the collections for April 2020.
- 2. Total Grants received in April 2021 amounted to \$8.9m, which was \$10.8m less than the target.
- 3. Total Current Expenditure, excluding principal repayments on debt, for the month of April was \$51.5m which was \$0.4m more than the \$51.1m targeted.
- 4. Capital Expenditure in April 2021 was \$12.3m, \$4.7m above the amount spent in April 2020 but well below the \$22.6m targeted for the month this year.
- 5. A primary surplus (including grants) of \$6.1m was recorded for the month of April 2021, which was \$6.4m more than the month's target and \$8.1m more than amount recorded in April 2020.
- 6. Principal Repayments on Debt for April 2021 was \$26.2m, while interest payments totaled \$3.1m.

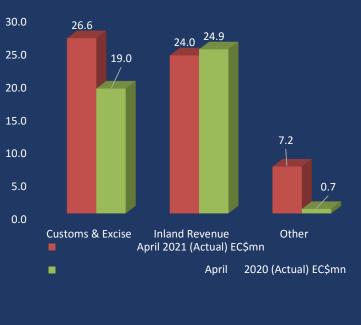
