

FISCAL SUMMARY February 2017

- 1. Current Revenue for February 2017 was \$53.4M, which was \$5.1M above the target and \$4.3M more than the collections for February 2016.
- 2. Grants received in February 2017 amounted to \$3.5M, which was \$9.1M below the targeted \$12.6M.
- 3. Total expenditure for the month of February was \$52.3M, \$13.1M below the targeted \$65.4M.
- 4. A primary surplus after grants of \$5.7M was realised for the month of February 2017, exceeding the projected deficit of \$2.8M.
