

# FISCAL SUMMARY January 2017

- 1. Current Revenue for January 2017 was \$60.4M, which was \$8.8M above the target and \$13.0M more than the collections for January 2016.
- 2. Grants received in January 2017 amounted to \$4.0M, which was \$7.7M below the targeted \$11.7M.
- 3. Total expenditure for the month of January was \$48.6M, \$6.2M below the targeted \$54.8M.
- 4. A primary surplus after grants of \$18.5M was realised for the month of January 2017, exceeding the targeted \$11.5M.
