

FISCAL SUMMARY June 2017

- 1. Current Revenue for June 2017 was \$58.0m, which was \$1.4m above the target but \$4.7m less than the collections for June 2016.
- 2. Grants received in June 2017 amounted to \$3.1m, which was \$9.1m below the targeted \$12.2m.
- 3. Total expenditure for the month of June was \$48.4m, \$11.4m below the targeted \$59.8m.
- 4. A primary surplus of \$16.2m was realized for the month of June 2017, which was above the projected surplus of \$13.6m.
