

FISCAL SUMMARY March 2019

- 1. Current Revenue for March 2019 was \$67.2m, \$6.8m less than the target and \$1.9m less than the collections for March 2018.
- 2. Total Grants received in March 2019 amounted to \$5.8m, which was \$2.2m less than the amount in March 2018.
- 3. Total current expenditure for the month of March was \$50.5m, \$4.8m less than the amount in March 2018 and \$3.3m less than the targeted \$53.8m.
- 4. A primary surplus (including grants) of \$22.6m was realised for the month of March 2019, less than the targeted \$24.1m, but exceeding the \$17.5m surplus recorded in March 2018.
