

FISCAL SUMMARY March 2020

- 1. Current Revenue for March 2020 was \$68.9m, which was \$2.7m lower than the target and \$0.9m more than the collections for March 2019.
- 2. Total Grants received in March 2020 amounted to \$6.4m, which was \$0.3m more than the amount received in March 2019.
- 3. Total current expenditure for the month of March was \$57.2m, \$3.6m more than the amount spent in March 2019 and \$3.1m more than the targeted \$54.1m.
- 4. A primary surplus (including grants) of \$16.8m was realised for the month of March 2020, which was less than both the targeted \$21.5m and the \$20.6m surplus recorded in March 2019.
