

FISCAL SUMMARY MAY 2017

- 1. Current Revenue for May 2017 was \$60.8m, which was \$3.7m above the target and \$7m more than the collections for May 2016.
- 2. Grants received in May 2017 amounted to \$4.4m, which was \$7.5m below the targeted \$11.9m.
- 3. Total expenditure for the month of May was \$68.3m, \$7.5m below the targeted \$75.8m.
- 4. A primary surplus of \$17.9m was realized for the month of May 2017, which was above the projected surplus of \$15.3m.
