

FISCAL SUMMARY October 2017

- 1. Current Revenue for October 2017 was \$58.1m, \$4.8m above the target for the month of October and \$4.7m above the 2016 October collections.
- 2. The amounts of grants spent to finance capital expenditure was \$1.6m.
- 3. Total expenditure for the month of October was \$47.6m, \$15.4m under the targeted \$63.0m.
- 4. A primary surplus of \$15.9m was realized for the month of October 2017, which was above the projected surplus by \$8.4m.
