

# FISCAL SUMMARY December 2015

- 1. A primary surplus of \$5.4m was realised for the month of December 2015.
- 2. Total revenue and grants amounted to \$68.7m while total expenditure reached \$70.6m. This resulted in an overall deficit of \$1.9m
- 3. Revenue collections for the month of December were significantly higher than expected. Actual receipts were \$9.7m above the target of \$59.0m; and were \$11.2m more than the collections for December 2014.
- 4. Grants received in December 2015 amounted to \$9.5m against a target of \$10.2m. This reduction was mainly due to the underperformance of the NTF grants.
- 5. Current expenditure was within projections, with actual spending amounting to \$38.1m as against a target of \$40.7m. This level of spending was \$4.6m less than the amount spent in December of 2014.
- 6. Capital expenditure amounted to \$32.5m in December 2015. This level of spending was above the \$14.3m projected and surpassed the \$23.3 spent in December 2014.
