

# FISCAL SUMMARY February 2016

- 1. Current Revenue for the month of February was \$46.8m, which is \$4.6m above the target. The amount collected is also \$6.2m more than the collections for February 2015
- 2. Grants received in February 2016 amounted to \$4.2m, which is below the target of \$11.2m
- 3. Total expenditure was \$57.5m
- 4. A primary deficit of \$2.9m was realised for the month of February 2016.
