

FISCAL SUMMARY January 2016

- 1. A primary surplus of \$11.2m was realised for the month of January 2016.
- 2. Total revenue and grants amounted to \$48.4m. However, total expenditure was only \$41.0m.
- 3. The Current Revenue target for the month of January was \$43.4m. The amount collected was \$47.2m, which was above the target by \$3.8m; and an increase of \$1.9m when compared to the collections for January 2015.
- 4. Grant receipts in January 2016 amounted to \$1.2m
